This warranty is extended only to the original end-use purchaser or the person receiving the product as a gift and shall not be extended to any other person or transferee.

The warranty is valid from the date of retail purchase for a period of 1 year.

In the case of a covered warranty defect, WASHENG will at its option: (A) repair the product using new or refurbished parts; (B) replace the product with an equivalent new or refurbished product; or (C) provide a partial or full refund of the original purchase price to you in exchange for return of the product.

A new warranty is valid from the date of the previous warranty claimed for a new period of 6 months if the original period of warranty is less than 6 months. Otherwise, the original period of warranty is valid.

This warranty does not cover defects or damage arising from improper use or maintenance, accident or external causes. Unauthorized repair, modification or customization of your product voids this warranty.

This warranty does not cover the built-in battery damage caused by no charging during a period over 6 months straight.

The warranty does not cover the USB cable and pouch or any accessories included in the retail package, except that those accessories are faulty upon receiving.

For warranty service on covered defects during the warranty period, WASHENG may require you to provide: (A) proof of purchase details, including but not limited to a receipt or sales invoice; (B) the speakerphone with defect; (C) your description of the defect; (D) your contact information.
